# Temporary Baggage Storage Agreement

To make your sightseeing more comfortable, we will temporarily store your baggage. The use of this service is subject to the terms and conditions of this agreement.

### 1. items that cannot be deposited

- ① Cash and other valuables, securities, passports, and other items deemed valuable.
- ② Remains, tablets, art works in general
- (3) Animals, plants, fish and shellfish
- 4) Hazardous materials and chemicals, such as volatile or explosive materials
- ⑤ Guns, swords, and objects that may be used for criminal purposes
- 6 Odoriferous, perishable, perishable, and unclean items
- (7) Items prohibited by Japanese law to be carried in one's possession
- 8 Other items deemed unsuitable for storage

## 2. usage fee

1,000 yen per piece per day per time (No size restrictions)

## 3. deposit period

From the time of deposit to 5:30 p.m. on the same day

\*\*Sunday and holidays: until 5:00 p.m.

XIf the deposit period is exceeded on the same day, an additional fee will be charged.

#### 4. Processing after the deposit period ends

If the storage period is exceeded and no notice is received, the Company will keep the bag for seven (7) days counting from the date of commencement of storage.

In this case, however, a charge will still be incurred in accordance with the provisions of these General Terms and Conditions.

#### 5. What to do if you deposit an item that cannot be deposited

If, during the deposit period or after the deposit period has expired, we suspect that the deposited item falls under Clause 1 (Deposit Unacceptable), we shall open, open, destroy, or otherwise appropriately dispose of the deposited item according to the circumstances.

We may open, destroy in custody, or take other appropriate measures in accordance with the circumstances.

### 6. In case of no pickup, etc.

We will dispose of any items left unclaimed after 7 days and apply the proceeds to storage fees and other expenses.

#### 7. liability for accidents

We shall not be liable for any loss of or damage to the deposited items in the following cases

- (ア) Loss of or damage to items listed in 1.(Items that cannot be deposited)
- (1) In the event of force majeure such as natural disasters, etc.
- (ウ) If, in the exercise of judicial authority or otherwise, the relevant government or public office requests that the information be submitted as evidence of an incident or accident in which you may have been involved.
- (工) In the event of loss or damage caused by a third party's tortious act.
- (オ) Other cases not attributable to us.
